INDIVIDUAL PERSONAL GUARANTY

In consideration for the extensions of credit by *Pratt Dudley Builders Supply Co.* to _____, hereafter known as customer, I _____, hereby personally and unconditionally guarantee to *Pratt Dudley Builders Supply Co.*, its successors and assigns, the full and prompt payment, when due, of all present and future obligations or indebtedness of the "CUSTOMER" to *Pratt Dudley Builders Supply Co.* I also personally guarantee payment of all costs incurred by *Pratt Dudley Builders Supply Co.* by reason of default of the "CUSTOMER", including 15% attorney fees of the principal and interest then due and owing if the same is placed in the hands of an attorney for collection or suit.

I waive notice of acceptance of this Guaranty, and notice of any default by the "CUSTOMER". I agree that *Pratt Dudley Builders Supply Co.* may, without notice and without affecting my liability under this Guaranty, enter into transactions with the "CUSTOMER", modify the terms of any agreements between *Pratt Dudley Builders Supply Co.* and the "CUSTOMER" or grant extensions of time or credit to the "CUSTOMER", or compromise, release, or assign any rights with respect to (1) the "CUSTOMER", or (2) myself, (3) any other guarantor of the "CUSTOMER'S" obligations and/or indebtedness to *Pratt Dudley Builders Supply Co.*, or (4) any collateral held by *Pratt Dudley Builders Supply Co.* as security under agreements between *Pratt Dudley Builders Supply Co.* and the "CUSTOMER".

Where there are one or more other guarantors of the "CUSTOMER'S" indebtedness or obligations to *Pratt Dudley Builders Supply Co.*, I agree that my liability shall be joint and several.

It shall not be necessary for *Pratt Dudley Builders Supply Co.*, in order to enforce this Guaranty, to first proceed against the "CUSTOMER". Nor shall *Pratt Dudley Builders Supply Co.* have any obligation to perfect or protect any security interest or any rights it may have in any collateral.

This Guaranty is a continuing guarantee of payment, not of collection, and shall remain in force until revoked by me by notice in writing to *Pratt Dudley Builders Supply Co.* However, such revocation shall be effective only as to those obligations or indebtedness of the "CUSTOMER" which arise out of the transactions entered into after receipt of notice of revocation by *Pratt Dudley Builders Supply Co.* This Guaranty is a primary and unconditional obligation and covers all existing and future obligations or indebtedness of the "CUSTOMER" to *Pratt Dudley Builders Supply Co.*

If action be instituted on this Guaranty, I promise to pay such sum as the Court may affix as attorney fees.
